Instructions

This form is intended to gather information related to financial need in conjunction with your need-based grant application. Unless otherwise agreed, Temple University, Japan Campus ("TUJ") will use the information collected herein only for the purposes of assessing financial need and making grant decisions. All information will be kept strictly confidential and not shared with any party, individual, or entity outside of the Temple University system.

When completing the application, it is important to (i) answer all questions about you (the student) and your family if you are a "dependent" as defined herein, and (ii) convert all currency figures to Japanese yen before entering them on the form; (iii) be as accurate as possible when answering questions about income, assets, and expenses.

For purposes of this form, the following definitions shall apply:

If the student is not married, then "family" means the student's parents and siblings, unless proof can be provided that the student is not a "dependent" as defined below. If a student is married, then "family" means the student's spouse and dependents.

In general, a student is considered to be a "dependent" if s/he receives parental financial support in any form. A student shall not be deemed a "dependent" if s/he:

- (1) is 24 years old or older;
- (2) is working on a masters or doctorate degree;
- (3) is married;
- (4) has children or dependents who receive more than half of their support from the student;
- (5) has lost both parents;
- (6) is or was a ward or dependent of the court;
- (7) is currently serving on active duty in the armed forces for purposes other than training; or
- (8) is a veteran of the armed forces.
