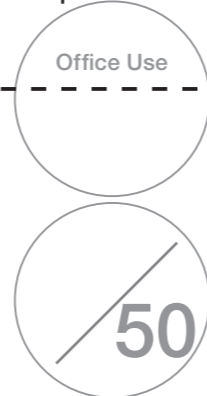

Waiver of Liability, Assumption of Risk, and Indemnity Agreement Already Signed

I accept and hereby assume all risks of personal injury, illness, death, and/or any damage to property which may occur during an Event.
