The TUJ Law U.S. Bar Exam Study Course is a comprehensive lecture series on techniques and strategies to take a U.S. state bar exam. The course is designed to introduce students to the structure of a bar exam, provide practical tips on studying for and taking the exam, and give students practice covering each part of the exam, the multistate/multiplechoice section ("the MBE"), state essays, and the multistate performance test ("MPT") questions. **NEW!** Students also can participate in three workshops that are one-day each: MPRE Workshop, Essay Workshop and MBE Workshop.
